

**TEXAS GAS SERVICE COMPANY NOTICE OF INTERIM RATE ADJUSTMENT**  
**West Texas Service Area Incorporated and Environs IRA filed March 13, 2020**

Texas Gas Service Company, a Division of ONE Gas, Inc. ("Company"), hereby gives notice to the public that on March 13, 2020, the Company filed with the Railroad Commission of Texas and the regulatory authorities with original jurisdiction over the incorporated areas of the West Texas Service Area ("WTSA") its 2019 Interim Rate Adjustment ("IRA") filing for gas services provided to approximately 254,622 residential, 14,188 commercial, 128 commercial air conditioning, 36 industrial, 1,229 public authority, 5 public authority air conditioning, 20 municipal water pumping, 18 commercial transportation, 15 industrial transportation, 11 public authority transportation, and 2 electrical cogeneration transportation customers within the incorporated and environs areas of the Company's WTSA. The 2019 IRA filing will increase rates for all customers in the WTSA which includes the incorporated and environs areas of Andrews, Anthony, Barstow, Crane, Clint, Dell City, El Paso, Horizon City, McCamey, Monahans, Pecos, Peyote, San Elizario, Socorro, Thorntonville, Vinton, Wickett, and Wink, Texas and the environs of Fabens and Canutillo, Texas. The effective date of the proposed change to rates is May 12, 2020.

The IRA filing is made pursuant to Tex. Util. Code Ann. §104.301. The interim rate adjustment will allow the Company to recover the incremental cost of its new investment made in the WTSA for the twelve-month period ending December 31, 2019. The Company expects that its revenues from the WTSA incorporated and environs customers will increase by approximately \$4,666,421 as a result of this change. In accordance with Tex. Util. Code Ann. § 104.101, the increase constitutes a major change in the Company's rates because the proposed changes will increase the total aggregate revenues of the Company's WTSA by more than two and one-half percent.

The 2019 IRA filing will increase the monthly average bill for all customers within the incorporated and environs areas of the Company's WTSA. The average monthly increase that each customer class will experience, excluding revenue-related fees and taxes, is shown in the table below.
