RE: Texas Gas Service Company Annual Reporting Requirement per Rate Schedule Pipeline
Integrity Testing (PIT) Rider for the West Texas Service Area

Texas Gas Service Company, a division of ONE Gas, Inc., (“TGS” or the “Company”) was authorized recovery of Pipeline Integrity Testing (“PIT”) expenses for the West Texas Service Area (“WTSA”) pursuant to Rate Schedule PIT Rider approved in the Final Order in Gas Utilities Docket No. 10506. TGS is filing this letter in compliance with the annual reporting requirements of the PIT Rider rate schedule.

For the calendar year ending December 31, 2019, the Company incurred Pipeline Integrity Testing expenses in the WTSA totaling negative \$7,645, due to some credits related to prior year testing activity. As a result of the 2019 annual PIT report, the Company was authorized to recover \$676,556. During the period April 2019 through December 2019, the Company recovered \$361,816. The Company estimates it will recover an additional \$361,816 during the period January through March 2020, leaving no balance uncollected. As a result of the 2018 annual PIT report, the Company was authorized to recover \$985,371. During the period April 2018 through March 2019, the Company recovered \$1,006,470, leaving an over-collected balance of \$22,636, which will be netted against the recovery during 2020 as set forth in the tariff. The Company has calculated a rate of negative \$0.00016 per Ccf to be refunded to customers for the 12-month period, April 2020 through March 2021.

Enclosed are a copy of the PIT-Rider tariff showing the negative \$0.00016 rate, a copy of the proposed Public Notice and supporting documentation. The proposed Public Notice follows the same format as that of the initial notice previously approved as required by the PIT Rider.

PUBLIC NOTICE
2020 WTSA Pipeline Integrity Testing Rider

Texas Gas Service Company, a division of ONE Gas, Inc., (the “Company” or “TGS”) hereby gives notice of rates to be charged from April 2020 through March 2021 under the Pipeline Integrity Testing (PIT) Rider applicable to the incorporated and adjacent unincorporated areas of Andrews, Anthony, Barstow, Clint, Crane, Dell City, El Paso, Fabens, Horizon City, McCamey, Monahans, Pecos, Pyote, Socorro, San Elizario, Thorntonville, Vinton, Wickett, and Wink, Texas in the Company’s West Texas Service Area (“WTSA”). The PIT Rider was approved by the Railroad Commission by Final Order dated September 27, 2016, in GUD No. 10506 for all unincorporated customers and for incorporated customers in Anthony, Clint, Dell City, El Paso, Fabens, Horizon City, Socorro, San Elizario, and Vinton, Texas. The PIT Rider was approved by the Cities of Andrews, Barstow, Crane, McCamey, Monahans, Pecos, Pyote, Thorntonville, Wickett, and Wink, Texas, on December 1, 2016. The PIT Rider permits the Company to recover the cost of pipeline safety testing that the Company is required to perform by law.

The effect of the PIT Rider on the various customer classes within the WTSA is set forth in the table below:

PIPELINE INTEGRITY TESTING (PIT) SURCHARGE RIDER

A. APPLICABILITY

The Pipeline Integrity Testing Surcharge (PIT) rate as set forth in Section (B) below is pursuant to Final Order in GUD 10506. This rate shall apply to the following rate schedules of Texas Gas Service Company in the incorporated and unincorporated areas of and adjacent to the West Texas Service Area (WTSA): 10, 20, 21, 30, 40, 41, 42, E5, SS, C-1, T-1, 1Z, 2Z, 2A, 3Z, 4Z, 4A, 4B, SS-ENV, C-1-ENV and T-1-ENV.

B. PIT RATE

\$(0.00016) per Ccf, (a refund)

This rate will be in effect until all approved and expended pipeline integrity testing expenses are recovered under the applicable rate schedules.

C. OTHER ADJUSTMENTS

Taxes: Plus applicable taxes and fees (including franchises fees) related to above.

D. CONDITIONS

Subject to all applicable laws and orders, and the Company's rules and regulations on file with the regulatory authority.
